I am asking that the members make every effort to attend this year's AGM. Your Board of Trustees needs your input so the meeting will focus on empowering the membership through break out sessions intended to generate ideas on a number of topics, including;

### FBGA Members' Allotment Garden

The FBGA Board wants to raise a committee at the AGM to take charge of this project.

#### The Idea

The Board has approved funds (\$1200) for the creation of a Members' Allotment Garden. We envisage a garden with a similar format and adjacent to the propagation beds. The funds are sufficient to build about a dozen raised beds. We believe a fee of \$25/bed/year will cover costs.

The allotment gardens are proposed as a member benefit which the Board hopes will attract new members and awaken gardening interest in those who may not garden at present.

Ideas on how it may work (committee to firm this up, report progress to the Site Development Committee Chair). Material changes to this plan will be referred to the Board by the Chair of the Site Development Committee.

Potential allotment holders will be required to subscribe and pay their fee by April 30, 2013.

They will participate in building the beds. Beds will be 4' x 8' in size.

Allotment holders are free to plant what they would like. They will maintain and weed their plots and undertake not to use pesticides.

Gardeners need to be aware that deer do wander through the garden and do sample the fare.

FBGA has had plant material stolen, so produce in the allotment gardens might suffer the same fate. Allotment holders' produce may be at risk.

Gardeners will need to bring their own tools. They can use water from the hoses on site.

The site is to be completely cleared for the winter and ready for the next year's planting by October 15.

Composting needs for the allotment garden will be determined and actioned by the committee and the gardeners.

## PROPOSAL TO AMEND FBGA BY-LAWS

*The Board of Trustees of the FBGA has approved the following change to By-law 4.02 of the Association relating to membership of the Board of Trustees, to be submitted to the Annual General Meeting in February 2013.*

### As standing

4.02 The Board of Trustees shall consist of nine elected members, except in 2009 not more than eleven elected members, and in 2010 and 2011 not more than *ten elected* members of the Association elected as follows:

- a) at each annual general meeting of the Association the members of the Association shall elect, for a term of three, two or one years each, enough members of the Association to the Board of Trustees to replace those members whose term has expired or have resigned, to make a Board of nine elected members. The lengths of the terms of the elected members shall be such that three members end their terms each year;
- b) the immediate Past President shall be a voting member of the Board of Trustees;
- c) in the event that a vacancy occurs on the Board of Trustees, the remaining Trustees may appoint a Trustee to serve until the next Annual General Meeting; at which Annual General Meeting a Trustee shall be elected by the members to complete the scheduled term of the Trustee whose position on the Board of Trustees became vacant;
- d) no Trustee shall serve more than three consecutive three year terms; after a lapse of one year a former Trustee may be reelected.

### Proposed change

4.02 The Board of Trustees shall consist of a maximum of ten members, one of whom shall be the immediate Past President of the Association.

(1) The Immediate Past President shall be a full voting member of the Board of Trustees and shall serve for one year.

(2) (a) All other members of the Board of Trustees shall be elected by a majority vote cast at the Annual General meeting.

(b) each of these Board of Trustee members shall be elected for a term of three years.

(c) in the event of a resignation or removal from the Board of Trustees, the remaining members of the Board of Trustees may appoint a person to the Board until the next AGM is held

(c)(i) at the next AGM, a replacement member shall be elected by majority vote of the association members present to complete the initial term of the Board Member being replaced.

(d) For the sake of continuity of the Board, it is desirable that the terms of elected Board members be staggered whenever possible.

(3) It is intended that the current members of the Board and their terms of office shall survive this amendment February 2013.
